



## MEMORANDUM OF UNDERSTANDING

#### BETWEEN

# INTERNATIONAL UNIVERSITY OF BUSINESS AGRICULTURE AND

## **TECHNOLOGY**

#### AND

# NAM CAN THO UNIVERSITY

International University of Business Agriculture and Technology(hereinafter referred to "IUBAT"), and Nam Can Tho University wishing to establish cooperative relations between the two institutions, especially to develop academic and cultural interchange between the two Universities in education, research, and other areas, agree to the following provisions:

#### Area

Subject to mutual consent, the area of cooperation includes any program offered at either university in which the two universities believe cooperation is feasible and desirable, and which would contribute to fostering and developing a mutually beneficial relationship between the two universities.

#### Methods

Subject to the approval of the Vice Chancellor of each university and the availability of resources, assistance shall be carried out through any one or more of the following activities or programs, or others currently not included in this list as mutually agreed to by the parties:

- 1. Exchange of faculty members/researchers
- 2. Exchange of students
- 3. Joint research activities
- 4. Participation in seminars, academic meetings and conferences
- 5. Exchange of academic materials and other information
- 6. Participation in trainings and special short-term academic programs
- 7. Participation in staff development projects
- 8. Study Tour

The terms of such activities shall be mutually discussed and agreed upon in writing and signed by both parties prior to the initiation of any particular program or activity. Each university will designate a liaison office to develop and coordinate specific activities and programs.

# Effective Date and Length of Agreement

This agreement will remain in force for a period of five (5) years from the date of signing (subject to the availability of funds). Any amendment and/or modification of this agreement require written approval of the President/Dean of each institution and shall be appended hereto. After the initial five-year period, this agreement shall be renewed automatically for the same duration in absence of six (6) months' written notice of its termination to the other party.

This agreement shall become effective immediately upon its being signed by the approved parties of both institutions.
